## **NOTICE OF ANNUAL GENERAL MEETING**

### **TWEED HEADS AND COOLANGATTA S.L.S.C.**

Notice is hereby given of the 110th Annual General Meeting of Tweed Heads and Coolangatta Surf Life Saving Club Incorporated.

*8.30am onwards for registration, membership renewal and annual report collection)*

### **ANNUAL GENERAL MEETING**

An Annual General Meeting of the Association shall be held in accordance with the provisions of the Act and on a date no later than two calendar months from the end of the financial year and at a venue to be determined by the Board.

### **NOTICE OF GENERAL MEETING**

- (a) Notice of every General Meeting shall be given to every Member entitled to receive notice, at the address appearing in the Register kept by the Association. The auditor and Directors shall also be entitled to notice of every General Meeting, which shall be sent to their last notified address. No other person shall be entitled as of right to receive notices of General Meetings.
- (b) Preliminary notice of a General Meeting should be issued 42 calendar days prior to the date of the meeting calling for notices of motion and any other business to be conducted at that meeting.
- (c) A notice of a General Meeting shall specify the place and day and hour of meeting and shall state the business to be transacted at the meeting.
- (d) At least 14 calendar days' notice of a General Meeting shall be given to those Members entitled to receive notice, together with:
  - (i) the agenda for the meeting; and
  - (ii) any notice of motion received from Members

### **BUSINESS**

- (a) The business to be transacted at the Annual General Meeting must include;
  - (i) recording of Attendance and Apologies;
  - (ii) confirmation of previous Annual Meeting Minutes;
  - (ii) presentation of the Annual Report of the Board;
  - (ii) presentation of the financial statement and audit report for the last financial year;
  - (iii) the election of Directors under this Constitution,
  - (iv) the motion for affiliation with the Branch, SLSQ and SLSA;
  - (v) the motion recognising the affiliation of the Association's supporters club;
  - (vi) the appointment of the auditors for the present financial year; and
  - (iv) general business without notice of the Association.

- (b) All business that is transacted at a General Meeting, and also all that is transacted at an Annual General Meeting, with the exception of those matters set down in clause 20(a) shall be special business.
- (c) No business other than that provided on the notice shall be transacted at that meeting.

### **NOTICES OF MOTION**

Members shall be entitled to submit notices of motion for inclusion as Special Business at a General Meeting. All notices of motion must be submitted in writing to the Secretary not less than 21 calendar days (excluding receiving date and meeting date) prior to the General Meeting. Notices of motion must include a mover and seconder.

*Only Members eligible to vote shall be entitled to submit notices of motion for inclusion as Special Business at a General Meeting.*

### **VOTING AT GENERAL MEETINGS**

#### **Members entitled to Vote**

Each Member over the age of 15 years and entitled to vote as set out in **clause 11.1** shall have one vote at General Meetings which, subject to this Constitution, shall be exercised by that Member.

*As per Section 11, Clause 11.1, Members, pages 11 to 13 of the Constitution:*

*Active, Reserve Active, Long Service, Past Active and Life Members have the right to be present, to debate and to vote at General meetings.*

*Probationary, Junior Activities (Nippers), Cadet and Honorary Members shall not have voting rights.*

*Associate, Award and Associate Junior Activities Parent Members shall not have voting rights unless elected to office or position, which is provided with voting rights by this constitution.*

#### **Casting Vote**

Where voting at General Meetings is equal, the chairman may exercise a casting vote.

### **SUBSCRIPTIONS AND FEES**

*As per Constitution Section 11 Clause 12 page 13*

The annual membership subscription (if any) and fees payable by Members to the Association, the time for and manner of payment shall be determined by the Board from time to time.

Such annual membership fees are payable for the ensuing season to be eligible to stand for office and vote at the Annual General Meeting.

### **QUORUM**

No business shall be transacted at any General Meeting unless a quorum is present at the time when the meeting proceeds to business. A quorum for General Meetings shall be 30 Voting Members over the age of 15 years. A quorum for Special General Meetings shall be 50 Voting Members over the age of 15 years of age or 20% of the Voting Members whichever is the greater.

### **PROXY'S**

Proxy voting shall not be permitted at any General Meeting.

As a business we also achieved a number of our goals this season placing the club in a very good position moving forward. I would like to say thanks to both Boards of Management, the Surf Club and our Supporters Club for your efforts in reaching these results in a time when it was very challenging to run a business.

We had set out to have our club debt free throughout this season and achieved it largely thanks to the efforts of our Supporters Club.

We also employed Grant Brown as our Surf Club Manager and he has proved to be a very good addition to our team.

Other business achievements included the new website in November 2020, the new audio visual equipment in October 2020 and of course the completion of the new storage area at the rear of the club in the last off season.

It will again be another busy off season for us as the recent council works around the club will be followed by the commencement of our Stage Three renovations.

Thanks in advance to our Building Committee for the works they have done in this space it truly will put us at the forefront of Surf Clubs on the Gold Coast once complete.

Thanks also to our two administrators Helen Carter and Helen Doyle and the good lads in the THC Old Boys for your contributions to the club again this year.

## **DEPUTY PRESIDENT'S REPORT**

The season started as we came out of Covid Lockdown and into our new world. Thankfully, the various Governments were splashing a bit of cash around, so we submitted several Grant Applications including:

The Queensland Government Department of Housing and Public Works assisted us with a Grant for \$13,940 to install our new Training Room Audio Visual System

The Queensland Government Small Business adaptation grant assisted us with \$7,634 for our new website.

The Gold Coast City Council assisted us with a Community Organization Assistance Grant for \$5000 for new Ipads for our Training and Proficiencies as we strive towards a paperless program.

The Gold Coast City Council assisted us with another recovery grant of \$2000 to assist us to clean and reopen the club.

The Australian Government released funds for the Beach Safety Equipment Fund once again and we were fortunate to receive \$5000 towards the cost of the new IRB.

We worked hard for grants to assist us renovating our admin office, fund a golf day, supplement our solar power system, reestablish our board riders shed and to assist with the Stage 3 Build, but they are either still in the respective government systems or unsuccessful. Whilst we managed to fund and complete the board riders shed the others are still in progress.

The Golf Day, however, without a Grant is very hard to turn into a respectable return for the amount of work and we remain focused on raising fund elsewhere.

Sunland Developments very generously assisted us with a deposit for a new IRB of \$5000 and fortunately for me our insurer has paid the insurance for the damaged IRB. We have two IRBs on order now with one due in June / July and the other September / October.

We interviewed several applicants for our office manager, and we were very successful with another Grant. Grant Brown has been the TH&C Surf Life Saving Club Manager since October. He is a contributing factor to the Surf Lifesaving Club getting another two years out of David Fuller as President which is fantastic

We attracted a beach rugby competition to our beach and after a fiery start and not much return we have sorted out a way for it to be a successful way of assisting the club with funds in the future. We will need volunteers to help us when the competition returns in October.

In the Off Season an Elite Athlete program and the works required to make the club ready for Stage 3 to be able to start is keeping us busy. Lots of information is coming.



Without our valuable patrol members, we could not provide this ongoing outstanding service to our community.

## **NIPPER REPORT**

### **2020/21 Season Overview**

- The club had 222 nippers registered, and 14 of these were under 15's (down from 18 the prior season), and the Nipper number is overall down 40%.
- Maintained high award attainment. TH&C had grown to be the largest in Point Danger Branch (PDB) over the previous eight (8) seasons, at its peak in season 2019/20 of 346 Nippers. Decrease by 40% is partly attributable to two matters - COVID-19 uncertainty and water safety concerns over marine activity early in the season.
- Nipper numbers have been 2012/13 – 139, 2013/14 – 178, 2014/15 - 207, 2015/16 - 211, 2016/17 – 220, 2017/18 – 270, 2018/19 – 343, 2019/20 – 346, and 2020/21 – 222.
- 175 new age awards allocated (u6 to u13).
- 22 (new) SRC awards allocated
- 24 new patrolling members
- \$68,000 nipper budget
- 9<sup>th</sup> overall at State Youth Champs (up from 12<sup>th</sup> 2018/19), and 4<sup>th</sup> on handicap score.
- 4<sup>th</sup> overall in PDB for u11-15's, 3<sup>rd</sup> overall in PDB for u8-10's.
- 4<sup>th</sup> overall in GCCT for u11-15's, 5<sup>th</sup> overall in GCCT Little Dudes for u8-10's.

Nippers is essentially about raising our kid's knowledge of the ocean and its surrounds how to handle themselves safely in the ocean. With our Sunday is Fun Day approach we can improve their skills without pressure with the hope that one day they will become a patrolling member of our club and keep our ocean safe for others.

There is also a competitive side of Nippers where the Clubs and kids get to compete against other clubs at a local (branch) and State level. For the up-and-coming season we are planning on introducing a sporting academy for the kids that are serious about the competition side of Nippers. It is an exciting prospect for our club to support our already dedicated young athletes and encourage and support our up and coming ones.

- Increase Family Participation, Ran family participation program
- TH&C Website, Renew online via Team App Website
- Christmas Raffle and Movie Night were fantastic
- Upstairs Raffle Spot was managed first class
- Competition, improved on 12<sup>th</sup> place at State in 2019 to a 9<sup>th</sup> place in 2021
- Finished Nipper Storage with new security gate and locks for boards
- BBQ and Beach Set up Roster for each age group worked well
- We purchased new foamy mals and rescue boards for U14's and Water safety for 2021/22

### Financial Report 2020-21 (Tracey Norris)

The 2020/21 season commenced with considerable uncertainty coming off the back of Covid and the fatal shark attack that occurred on 7 September 2020. There was much uncertainty around nipper memberships and also generating sponsorship with many businesses being hard-hit with a covid downturn.

Fortunately, the prior season had seen much investment in equipment and training and we were well placed to conduct the season where new funding was not certain.

It transpired that our membership fees, fundraising and sponsorship was about \$30,000 down on the prior year and we were carrying about

a \$10k deposit from the 200 club that was collected in FY20, that was still to be conducted at the time of the Nipper AGM; therefore this money was not able to be committed to expenditure until the event could be completed. But with prudent management of expenses and selective spending during the season, we were able to meet our expenses and acquire necessary items when required.

The deficit for the current year was \$8,222 but this included new rescue mal purchases at the end of the season: this was overdue as many of the foam mals had perished. This deficit is subsidised by the main club throughout the year; their contribution it assist us to meet our operating costs including surf and beach coach fees and is very much appreciated.

The projected cash balance at the end of the season is \$23,000 which is similar to the funds at the commencement of the season .

Note that the 200 club carried forward from fy20 was conducted subsequent to the Nipper AGM and is factored into the estimated closing cash balance.

## **BUILDING COMMITTEE REPORT**

The third and final stage of the club's redevelopment is underway with completion of design work anticipated for the end of June.

We have commenced the third stage at a very busy time within the building industry and design has taken longer than expected. We are still anticipating tendering early works packages in July.

Work will be undertaken in three separate stages to enable the supporters club to continue trading throughout the duration of the project. Work to the Training Centre is being undertaken outside the main building contract and managed by the surf club in order to complete this work prior to the start of next season.

The third stage of the redevelopment will achieve a clear and distinct separation between supporters club and surf club facilities. Installation of a covered area outside the training centre is being worked on to compensate for the loss of covered seating within the club's leased area on the kiosk side.

Relocation of the surfboard storage shed is also being considered with the likely home being new storage in the rear compound

Our builder Hutchinson's are currently preparing a preliminary cost estimate based on completed design to date. I expect to be able to provide the estimate at the AGM and follow up fairly soon after with a construction program and firmer estimate of cost.

The project GF, FF and Staging Plans are included

Work to the Training Centre includes:

- New surf club entry and access to amenities and storage areas
- An operable, acoustic wall that divides the Training Centre
- Internal upgrade to the surf club offices

The staged works comprising the main building contract are summarised as follows:

### Stage 1

- New entry and reception, including new lift
- New first aid room
- Male and female toilets to new function room
- Temporary relocation of supporters office to Training Centre

### Stage 2

- New function room in areas previously used as boardroom, supporters office and main entry to club
- New supporters office and storage rooms
- Decommissioning and removal of existing lift
- New Admin Store
- Air conditioning to supporters office and function room

### Stage 3

- Refurbishment of bar and dining room
- Refurbishment of female and male toilets
- Air conditioning to internal dining and bar areas
- Installation of goods lift from Duty Manager's office to GF Stores and Deliveries
- Removal of stairs in current DOSA area, relocation of DOSA to back (southern wall) of club and refurbishment of deck previously used as the DOSA, including sliding door access from bar area (note that this work relies on the club achieving compliance with fire codes and is yet to be finalised with the fire engineer).

At this stage it is anticipated that external landscaping will be undertaken by the Old Boys following consultant's design.

Appreciation is extended to Craig Hickling whose experience and skills within the building industry has proved invaluable.

I believe the completion of the third and final stage will continue to see Tweed Heads and Coolangatta SLSC prosper and remain one of the pre eminent and sought after clubs on the Gold Coast.

## **TREASURER'S REPORT**

Who would have thought this time last year we still would have been dealing with a pandemic and that we would have come out of it relatively unscathed? Thanks to the Government's Jobkeeper and Cashflow Boost of almost \$66,000 to the Surf Club and further monies to the Supporters Club we fared reasonably well.

We have managed to reduce the loan by almost half a million dollars....with a balance of only \$1,085 (the loan deliberately being kept open to help assist fund the 3<sup>rd</sup> stage renovations of the Club. The continuing success of the Supporters Club is allowing the Club to instigate the final stages of its renovations and fund new future growth programs for the Club.

As you can see in the accounts we have started accruing for unused leave this has resulted in an adjustment to the prior year periods of some \$28,722. Unused leave will now be accounted for annually in our accounts.

Again I would like to thank the Supporter's Club committee, management and staff for their continued great efforts with their donations to the Surf Club amounting to \$542,000

This amount was larger than the previous years \$533,000 and considering the effect that the pandemic had on hospitality this continued support is to be commended.

My fellow committee from the President down have all done a great job getting us through a tough year and I thank them all. But from a financial side, I would like to particularly thank the Deputy President, Vaughn Thomas. Vaughn has applied very successfully for almost every grant going and assisted with costing all of the various building/renovation projects underway or now completed – a lot of the new equipment or renovations that you see or use around the Club is directly due to Vaughn's efforts.

Lastly I would like to thank the administration staff of the Club, they again have made my job easy. The Helens together with our new manager Grant Brown have heralded a new era of the Club, a professional team of administrators working closely with the elected committee.

**Operating Result**



**NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Corporate Information**

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act and the Australian Charities and Not-for-profits Commission Act. The committee has determined that the association is not a reporting entity.

**Basis of Preparation**

The financial statements are for the Tweed Heads and Coolangatta Surf Life Saving Club Inc as an individual entity, incorporated and domiciled in Australia. The Tweed Heads and Coolangatta Surf Life Saving Club Inc is an association incorporated in Queensland under the Associations Incorporation Act and is registered as a charity under the Australian Charities and Not-for-profits Commission Act.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following Australian accounting standards have been applied in the preparation of these financial statements:

- AASB 101 - Presentation of Financial Statements
- AASB 107 - Statement of Cash Flows
- AASB 108 - Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1048 - Interpretation of Standards
- AASB 1054 - Australian Additional Disclosures

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

**Accounting Policies**

**a. Income Tax**

No provision for income tax has been raised as the association is exempt from income tax under Section 50-10 of the Income Tax Assessment Act. Tweed Heads and Coolangatta Surf Life Saving Club Inc is a Public Benevolent Institution (PBI) and has been endorsed by the Australian Taxation Office to receive tax concessions. Further, Tweed Heads and Coolangatta Surf Life Saving Club Inc is endorsed as a Deductible Gift Recipient (DGR).

**b. Comparative Figures**

When required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year. When required, comparative information is reclassified where appropriate to enhance comparability.

**c. Economic Dependence**

Tweed Heads and Coolangatta Surf Life Saving Club Inc is dependent on the Tweed Heads & Coolangatta Surf Life Saving Supporters Association Inc for funds used to meet its financial commitments. At the date of this report the committee members have no reason to believe the Tweed Heads & Coolangatta Surf Life Saving Supporters Association Inc will not continue to support Tweed Heads and Coolangatta Surf Life Saving Club Inc.

**d. Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Statement of Financial Position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

**e. Critical Accounting Estimates and Judgments**

The committee of management evaluate estimates and judgments in the financial report based on historical knowledge and best available information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the association.

***Key estimates***

The estimate of the useful life of leasehold improvements, plant and equipment is reviewed at least annually to confirm that the remaining life of material assets is reflected on the asset register. There were no other critical accounting estimates to be considered during the year or during preparation of this financial report.

***Key judgments***

The methods of depreciation are used to provide a consistent usage of the useful life of leasehold improvements, plant and equipment. The methods also allow, where required, for the leasehold improvements, plant and equipment to be fully written down at a specific point in time such as the end of the lease term. There were no other critical accounting judgments made by the committee of management.

**f. Contributions**

If and when Tweed Heads and Coolangatta Surf Life Saving Club Inc receives non-reciprocal contributions from the government or other parties for nothing or a nominal value the contributions would be recognised at the fair value on the date of acquisition upon which time an asset is taken up in the Statement of Financial Position and revenue in the Statement of Profit or Loss and Other Comprehensive Income.

**g. Revenue**

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Grant revenue is recognised in the Statement of Profit or Loss and Other Comprehensive Income when the association obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the association and the amount of the grant can be measured reliably.

Donations and bequests are recognised as revenue when received.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

**h. Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of twelve months or less, and bank overdrafts.

**i. Trade and Other Receivables**

Trade and other receivables include amounts due from members as well as amounts receivable from other entities. Receivables expected to be collected within twelve months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

**j. Inventories**

Inventories are measured at the lower of cost and net realisable value.

**k. Property, Plant and Equipment**

Each class of leasehold improvements, plant and equipment is carried at cost or fair value less, where applicable, accumulated depreciation and impairment losses.

***Leasehold improvements, plant and equipment***

Leasehold improvements, plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of leasehold improvements, plant and equipment is greater than its estimated recoverable amount, the carrying amount is written down immediately to its estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1n for details of impairment).

Leasehold improvements, plant and equipment that have been contributed at no cost, or for nominal cost, are valued and recognised at the fair value of the asset at the date it is acquired.

***Depreciation***

The depreciable amount of leasehold improvements, plant and equipment is depreciated on a straight line basis over the asset's useful life to the association commencing from the time the asset is held ready for use. The rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the Statement of Profit or Loss and Other Comprehensive Income. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained surplus.

**l. Trade and Other Payables**

Trade and other payables represent the liabilities for goods and services received by the association during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within thirty days of recognition of the liability.

**m. Employee Benefits**

***Retirement benefit obligations - superannuation benefits***

All employees of the association receive defined contribution superannuation entitlements, for which the association pays the fixed superannuation guarantee contribution (currently 9.5% of the employee's average ordinary salary) to the employee's superannuation fund of choice. All obligations for unpaid superannuation guarantee contributions are measured at the (undiscounted) amounts expected to be paid when the obligation is settled and are recognised as trade and other payables under current liabilities in the association's Statement of Financial Position.

***Short-term employee benefits***

Provision is made for the association's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service, including wages, salaries, annual leave and long service leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled. The association's obligations for short-term employee benefits are recognised as trade and other payables under current liabilities in the Statement of Financial Position.

**m. Employee Benefits (continued)**

***Long-term employee benefits***

The association only classifies employees' long service leave entitlements as long-term employee benefits as they are not expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service. Provision is made for the association's obligation for long-term employee benefits, which are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Upon the remeasurement of obligations for long-term employee benefits, the net change in the obligation is recognised in profit or loss classified under employee benefits expense.

The association's obligations for long-term employee benefits are recognised as provisions under non-current liabilities in its Statement of Financial Position, except where the association does not have an unconditional right to defer settlement for at least twelve months after the end of the reporting period, in which case the obligations are recognised as trade and other payables under current liabilities in the Statement of Financial Position.

**n. Impairment of Assets**

At the end of each reporting period, the committee members assess whether there is any indication that an asset may be impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount in accordance with another Standard (e.g. in accordance with the revaluation model in AASB 116). Any impairment loss of a revalued asset is treated as a revaluation decrease in accordance with that other Standard.

Where it is not possible to estimate the recoverable amount of an individual asset, the committee members estimate the recoverable amount of the cash-generating unit to which the asset belongs.

**o. Leases**

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term.

**p. Change in accounting policy**

The committee determined that annual leave, long service leave and associated on-costs be recognised in the financial statements at year end. This resulted in a prior period adjustment for the leave and on-costs accrued prior to 01 May 2020.




