NOTICE OF ANNUAL GENERAL MEETING

TWEED HEADS AND COOLANGATTA S.L.S.C.

Notice is hereby given of the 111th Annual General Meeting of Tweed Heads and Coolangatta Surf Life Saving Club Incorporated.

8.30am onwards for registration, membership renewal and annual report collection)

ANNUAL GENERAL MEETING

An Annual General Meeting of the Association shall be held in accordance with the provisions of the Act and on a date no later than two calendar months from the end of the financial year and at a venue to be determined by the Board.

NOTICE OF GENERAL MEETING

- (a) Notice of every General Meeting shall be given to every Member entitled to receive notice, at the address appearing in the Register kept by the Association. The auditor and Directors shall also be entitled to notice of every General Meeting, which shall be sent to their last notified address. No other person shall be entitled as of right to receive notices of General Meetings.
- (b) Preliminary notice of a General Meeting should be issued 42 calendar days prior to the date of the meeting calling for notices of motion and any other business to be conducted at that meeting.
- (c) A notice of a General Meeting shall specify the place and day and hour of meeting and shall state the business to be transacted at the meeting.
- (d) At least 14 calendar days' notice of a General Meeting shall be given to those Members entitled to receive notice, together with:
 - (i) the agenda for the meeting; and
 - (ii) any notice of motion received from Members

BUSINESS

- (a) The business to be transacted at the Annual General Meeting must include;
 - (i) recording of Attendance and Apologies;
 - (ii) confirmation of previous Annual Meeting Minutes;
 - (ii) presentation of the Annual Report of the Board;
 - (ii) presentation of the financial statement and audit report for the last financial year;
 - (iii) the election of Directors under this Constitution,
 - (iv) the motion for affiliation with the Branch, SLSQ and SLSA;
 - (v) the motion recognising the affiliation of the Association's supporters club;
 - (vi) the appointment of the auditors for the present financial year; and
 - (iv) general business without notice of the Association.

- (b) All business that is transacted at a General Meeting, and also all that is transacted at an Annual General Meeting, with the exception of those matters set down in clause 20(a) shall be special business.
- (c) No business other than that provided on the notice shall be transacted at that meeting.

NOTICES OF MOTION

Members shall be entitled to submit notices of motion for inclusion as Special Business at a General Meeting.

All notices of motion must be submitted in writing to the Secretary not less than 21 calendar days (excluding receiving date and meeting date) prior to the General Meeting. Notices of motion must include a mover and seconder.

Only Members eligible to vote shall be entitled to submit notices of motion for inclusion as Special Business at a General Meeting.

VOTING AT GENERAL MEETINGS

Members entitled to Vote

Each Member over the age of 15 years and entitled to vote as set out in **clause 11.1** shall have one vote at General Meetings which, subject to this Constitution, shall be exercised by that Member.

As per Section 11, Clause 11.1, Members, pages 11 to 13 of the Constitution:

Active, Reserve Active, Long Service, Past Active and Life Members have the right to be present, to debate and to vote at General meetings.

Probationary, Junior Activities (Nippers), Cadet and Honorary Members shall not have voting rights.

Associate, Award and Associate Junior Activities Parent Members shall not have voting rights unless elected to office or position, which is provided with voting rights by this constitution.

Casting Vote

Where voting at General Meetings is equal, the chairman may exercise a casting vote.

SUBSCRIPTIONS AND FEES

As per Constitution Section 11 Clause 12 page 13

The annual membership subscription (if any) and fees payable by Members to the Association, the time for and manner of payment shall be determined by the Board from time to time.

Such annual membership fees are payable for the ensuing season to be eligible to stand for office and vote at the Annual General Meeting.

QUORUM

No business shall be transacted at any General Meeting unless a quorum is present at the time when the meeting proceeds to business. A quorum for General Meetings shall be 30 Voting Members over the age of 15 years. A quorum for Special General Meetings shall be 50 Voting Members over the age of 15 years of age or 20% of the Voting Members whichever is the greater.

PROXY'S

Proxy voting shall not be permitted at any General Meeting.

DIRECTOR OF SURF LIFESAVING'S REPORT

The 21-22 surf lifesaving season has come to a close, what a season it was, where do I start? The season did not start smoothly due to ongoing covid restrictions. The Qld government restricted all NSW residents from crossing the border. That was a big blow to TH&C as 70% of our members come across from NSW. We had released a patrol roster that we had to try to reconfigure with our Qld members taking the patrols on all by themselves. Luckily, at the last minute, the QLD Government decided to give all patrolling members from NSW an exemption to cross the border to patrol along with members who were entering the state for education which allowed us to get all members proficient.

Surf Life Saving Queensland introduced a vaccine mandate for all members over the age of 16 making it necessary for members to be vaccinated prior to April 30 to continue to fulfil their patrolling obligations. Which put us in a difficult position with a large number of members not able to patrol. A lot of people were unsure as to where they stood, but as always, we stood strong and carried on.

We had some very big seas in the new year with some outstanding rescues from a few patrols. We had the torrential rain which seemed like it was never going to stop, causing terrible floods. Some of our members went down to help in the IRBs in the Chinderah area, to drop food and water to people that were unable to get out of their flooded homes and also assisted in taking people to safety.

I must say, when members were asked, we were inundated with people wanting to lend a hand, it made me feel very lucky and privileged to be a part of this club. Not only the IRBs but people offering to make sandwiches and work at the shelters, it was amazing.

Continuing on from that for the next two months the water quality was very poor which made it hard again on the beach. At one stage the count was that there had been rain for 19 weekends out of 23. Eventually, we got there in the end. So, to all those remarkable people who turned up to help out, if it was 1 patrol to 100, thank you and I look forward to working with you all again next season.

EDUCATION AND TRAINING.

It has been a very strange year and thankfully it looks like we are nearly over all the bad stuff we have encountered. Training has been sporadic, with people finding it increasingly difficult to attend lengthy training sessions. Unfortunately, we are unable to take shortcuts with the SRC/ Bronze and IRB training as standards are set and must be maintained for every one's benefit. We have however been successful with our September School Holiday intense training. This course attracts fairly large numbers with a lot of people expressing interest in attending more of these. In fact, we ran a second one in December last year which was also well attended. It is the Training Teams intention to perhaps run three of these intense weekly duration courses each year during school holidays. This is dependent upon participant interest and the ability to provide adequate resources to run them.

These courses will be for SRC/Bronze only at this stage.

Being run through the week it is difficult to find Trainers and water safety personnel to attend. Fortunately, I am in a position to attend, while Chris Van Dorn usually takes a week off work to also do the training. Amanda Higgerson is usually available to help, although this year she is competing in the Worlds and is unable to assist. The rest of the Training Team usually assist on the weekend. Rather than have the tribulations of this year break the club, we saw the Nipper families unite like never before to ensure another successful season. The smiles on the faces of kids and parents alike said it all, and we successfully delivered another 16 competent and dedicated patrol members to the club. I'd like to thank everyone for their assistance and dedication this season, and we close it out knowing that we are in very good stead to grow and see success for the coming years.

Financial Update

With fundraising and membership revenue down this season, we still managed to deliver a successful season on reduced revenues of \$62,000. Equipment requirements were largely made during the previous two seasons, so we were able to direct our funds to directly supporting beach and competition activities and supporting club families through the season. We both rationalised and expanded the clothing range, and hold good stock levels going into next year. Despite running at a deficit of about \$7,000, we will start next season with about \$20,000 at bank.

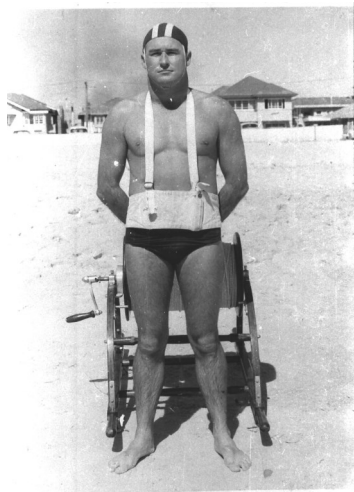
I'm hoping by the time this report goes to print the loan approval will have been received and we will finally start to see some progress.

IN MEMORY OF JOHN CUNNINGHAM March 20, 1933 – April 30, 2022.



If there was a category in the Guinness Book of Records for surf lifesaving, John Cunningham would feature strongly. For more than half a century he stamped himself as a unique person who deserves a category of his own as an inspirational and distinguished member of the Greenmount Club.

It was once said that a professional is someone who does his or her best - even when they don't feel like it. Well, that doesn't start to describe John Cunningham - he always delivered his best and was always ready for it. It would be easy with the nostalgia that surrounds the former surf champion not to remember how significant he was. John Cunningham was a man with as much surfing class as surfing character.

Cunny, as he is better known, came to surf lifesaving through a strong family link His father Chris - who couldn't swim was a TH&C supporter from the very early days and a very dedicated committee man. Cunny's uncles, John and Pat Cunningham and Raymond 'Nudge' Noonan, were members of TH&C and as a youngster Cunny couldn't wait to become old enough to be a lifesaver and to play rugby league. He said "it was what every young fellow wanted to do" So as soon as he was big enough he joined a squad of youngsters being taught the basics of swimming by Peter Winter in the Back Channel (now Greenbank) of the Tweed River at Tweed Heads. "I never really learned to swim properly; I was self-taught with Peters help. He joined the surf club in 1947 as a cadet.

He went to Woodlawn College in Lismore where he trained for his Bronze and was qualified at 15 years and nine months. The required age was 16 and, although the paperwork went through.

Cunny never saw his Bronze until Alan Johnson tracked it down in 2006.

He was an extraordinary role model and although his name appears many times on the Club's honour board and he has swags of Club, Branch, and State titles to his credit, Cunny didn't see himself as anything different to any other surf lifesaver "The beach was the place to be when he was a youngster, It offered good times and good friendship. Although he frequently denied it, his reputation as an amiable and brilliant surf competitor was an inspiration to many Tweed district teenagers and he soon helped to encourage a group of Murwillumbah locals to join the surf club.

In 1962 Cunny was asked to fill in as a Gold Coast City Council lifeguard patrolling at Kirra. He liked the role and he stayed on until he retired in 1995 In all surf lifesaving dominated 55 years of his life.

Cunny received two meritorious bravery awards a Bronze Medal from the Royal Shipwreck Relief and Humane Society of Australia and a Bronze Medallion from the Surf Life Saving Association of Australia. For his efforts rescuing two young life savers who were swept out to sea after trying to rescue another young man off Kirra Beach on Australia Day weekend of 1967 the rescue gaining tremendous publicity around the world.

It was even said at one time that he saved the life of the then Prime Minister Gough Whitlam when he surfed at Duranbah during an official visit to the district in 1973. However, Cunny denies this, explaining that although he was the Gold Coast City Council lifeguard based at Greenmount he had been handpicked to swim alongside the PM as he enjoyed the NSW surf.

. Congratulation to James Small — O.A.M.

Active Long Service member James Small has been included in this year's Australia Day Honours Awards receiving an Order of Australia Medal. His O.A.M. is for services to Surf Life Saving and at age 71 it is a culmination of a life long commitment.

His first Commonwealth Award was invested in 2010 as a Commendation for Bravery (CBM). James has received a long list of Awards including South Coast Life Saver of the Year 2002/2003, Ulladulla's Best Citizen Australia Day Award 2001, Inaugural and Perpetual Quiet Achiever of the Year 2003, Mayoral Citation for fighting bushfires 2002, Mollmook Patrol Person of the Year 2003/2004/2005, Tweed Heads & Coolangatta SLSC Club Person of the Year 2015, Official Citation from the Indonesian Government for introducing Surf Life Saving to Nembralia High School, Roti Island, West Timor 2015.

In total James has accumulated in excess of 4300 Patrol hours since 2000 signing on in QLD, NSW, WA. and NZ. (12 clubs in total). Nearly 2600 hours patrolling Greenmount Beach.

James (Jim) has volunteered on many patrols at TH&C and in doing so has become a well liked and respected by many club members from our younger members to our masters.

On receipt of an Order of Australia, James provided the following insight and inspirational statements.

"I have found enormous joy mentoring, coaching, career advising, counselling and simply being a friend to our youth. Many mentors have impacted my own life and for their input I am eternally grateful and as such this award is as much theirs as mine. This is history repeating itself! I have been approached on numerous occasions particularly for entry into the Navy, Air Force and Army to issue references."

" My junior years at Maroubra Surf Club under the guidance of my father James Small Snr.
(a highly respected Life Member) laid the foundation for my Surf Lifesaving commitment!"

CLAYTON'S STORY

Mr Clayton James SCHILG, Mansfield QLD 4122 Mr Clayton Schilg displayed considerable bravery during the rescue of people from a rip at Wooyung Beach near Pottsville, New South Wales on 9 January 2020. At around 2:00pm, Mr Clayton Schilg, then aged 14 years, and a friend were at Wooyung Beach when they became aware of a group of people approximately 50 metres from shore calling for assistance. The swimmers were caught in a rip and being dragged out behind the break. Whilst his friend contacted Mr Schilg's parents, he grabbed a battered foam surfboard that had been left on the beach and paddled towards the group in distress. He first reached two women, who confirmed they were safe and were able to make their own way back to shore. He paddled further out to where four men were in difficulty, one of the swimmers was going under and was in a bad way. Mr Schilg was able to pull him onto the board and instructed the other three to swim to him as the rip was pulling them all in different directions. One of the other three panicked on reaching him and pulled him down however, he was able to get himself free. He instructed two of the swimmers to hang onto the board and the remaining swimmer to hold onto his waist. He positioned himself at the front of the board and began paddling towards a sandbank. On reaching the sandbank the man holding onto his waist let go and made his way to safety. He continued to paddle the board with the other three swimmers towards the shore. As the group got closer other beachgoers came out to assist. On reaching the shore he placed the man on top of the board into the recovery position as he had ingested a large amount of water. He and others monitored the man until paramedics arrived.

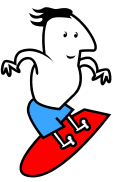
In due course you will be invited to attend an Investiture ceremony at which you will be presented with the insignia of your award.

Operating Result



NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Corporate Information

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 1981* (Qld) and the *Australian Charities and Not-for-profits Commission Act 2012* (Cth). The committee has determined that the association is not a reporting entity.

Basis of Preparation

The financial statements are for the Tweed Heads and Coolangatta Surf Life Saving Club Inc as an individual entity, incorporated and domiciled in Australia. The Tweed Heads and Coolangatta Surf Life Saving Club Inc is an association incorporated in Queensland under the *Associations Incorporation Act 1981* (Qld) and is registered as a charity under the *Australian Charities and Not-for-profits Commission Act 2012* (Cth).

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following Australian accounting standards have been applied in the preparation of these financial statements:

- AASB 101 - Presentation of Financial Statements
- AASB 107 - Statement of Cash Flows
- AASB 108 - Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1048 - Interpretation of Standards
- AASB 1054 - Australian Additional Disclosures

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Accounting Policies

a. Income Tax

No provision for income tax has been raised as the association is exempt from income tax under Section 50-10 of the *Income Tax Assessment Act 1997* (Cth). Tweed Heads and Coolangatta Surf Life Saving Club Inc is a Public Benevolent Institution (PBI). Further, Tweed Heads and Coolangatta Surf Life Saving Club Inc is endorsed as a Deductible Gift Recipient (DGR).

b. Comparative Figures

When required by the applied Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year. When required, comparative information is reclassified where appropriate to enhance comparability.

c. Economic Dependence

Tweed Heads and Coolangatta Surf Life Saving Club Inc is dependent on the Tweed Heads & Coolangatta Surf Life Saving Supporters Association Inc for funds used to meet its financial commitments. At the date of this report the committee members have no reason to believe the Tweed Heads & Coolangatta Surf Life Saving Supporters Association Inc will not continue to support Tweed Heads and Coolangatta Surf Life Saving Club Inc.

d. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Statement of Financial Position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

e. Critical Accounting Estimates and Judgments

The committee of management evaluate estimates and judgments in the financial report based on historical knowledge and best available information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the association.

Key estimates

The estimate of the useful life of leasehold improvements, plant and equipment is reviewed at least annually to confirm that the remaining life of material assets is reflected on the asset register. There were no other critical accounting estimates to be considered during the year or during preparation of this financial report.

Key judgments

The methods of depreciation are used to provide a consistent usage of the useful life of leasehold improvements, plant and equipment. The methods also allow, where required, for the leasehold improvements, plant and equipment to be fully written down at a specific point in time such as the end of the lease term. There were no other critical accounting judgments made by the committee of management.

f. Contributions

If and when Tweed Heads and Coolangatta Surf Life Saving Club Inc receives non-reciprocal contributions from the government or other parties for nothing or a nominal value the contributions would be recognised at the fair value on the date of acquisition upon which time an asset is taken up in the Statement of Financial Position and revenue in the Statement of Profit or Loss and Other Comprehensive Income.

g. Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Grant revenue is recognised in the Statement of Profit or Loss and Other Comprehensive Income when the association obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the association and the amount of the grant can be measured reliably.

Donations and bequests are recognised as revenue when received.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

h. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of twelve months or less, and bank overdrafts.

i. Trade and Other Receivables

Trade and other receivables include amounts due from members as well as amounts receivable from other entities. Receivables expected to be collected within twelve months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

j. Inventories

Inventories are measured at the lower of cost and net realisable value.

k. Property, Plant and Equipment

Each class of leasehold improvements, plant and equipment is carried at cost or fair value less, where applicable, accumulated depreciation and impairment losses.

Leasehold improvements, plant and equipment

Leasehold improvements, plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of leasehold improvements, plant and equipment is greater than its estimated recoverable amount, the carrying amount is written down immediately to its estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1n for details of impairment).

Leasehold improvements, plant and equipment that have been contributed at no cost, or for nominal cost, are valued and recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of leasehold improvements, plant and equipment is depreciated on a straight line basis over the asset's useful life to the association commencing from the time the asset is held ready for use. The rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the Statement of Profit or Loss and Other Comprehensive Income. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained surplus.

l. Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the association during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within thirty days of recognition of the liability.

m. Employee Benefits

Retirement benefit obligations - superannuation benefits

All employees of the association receive defined contribution superannuation entitlements, for which the association pays the fixed superannuation guarantee contribution (currently 10.0% [10.5% from 01 July 2022] of the employee's average ordinary salary) to the employee's superannuation fund of choice. All obligations for unpaid superannuation guarantee contributions are measured at the (undiscounted) amounts expected to be paid when the obligation is settled and are recognised as trade and other payables under current liabilities in the association's Statement of Financial Position.

Short-term employee benefits

Provision is made for the association's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service, including wages, salaries, annual leave and long service leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled. The association's obligations for short-term employee benefits are recognised as trade and other payables under current liabilities in the Statement of Financial Position.

m. Employee Benefits (continued)

Long-term employee benefits

The association only classifies employees' long service leave entitlements as long-term employee benefits as they are not expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service. Provision is made for the association's obligation for long-term employee benefits, which are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Upon the remeasurement of obligations for long-term employee benefits, the net change in the obligation is recognised in profit or loss classified under employee benefits expense.

The association's obligations for long-term employee benefits are recognised as provisions under non-current liabilities in its Statement of Financial Position, except where the association does not have an unconditional right to defer settlement for at least twelve months after the end of the reporting period, in which case the obligations are recognised as trade and other payables under current liabilities in the Statement of Financial Position.

n. Impairment of Assets

At the end of each reporting period, the committee members assess whether there is any indication that an asset may be impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount in accordance with another Standard (e.g. in accordance with the revaluation model in AASB 116). Any impairment loss of a revalued asset is treated as a revaluation decrease in accordance with that other Standard.

Where it is not possible to estimate the recoverable amount of an individual asset, the committee members estimate the recoverable amount of the cash-generating unit to which the asset belongs.

o. Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term.





Helen, you have been an Inspiration to many and will be sorely missed.

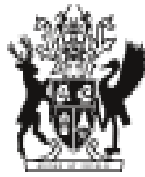
