NOTICE OF ANNUAL GENERAL MEETING

Notice is hereby given of the 112th Annual General Meeting of
Tweed Heads and Coolangatta Surf Life Saving Club Inc.

- WHEN :** Sunday 25th June 2023
- TIME :** 10:00am
(8.30am onwards for registration, membership renewal and annual report collection)

ANNUAL GENERAL MEETING

An Annual General Meeting of the Association shall be held in accordance with the provisions of the Act and on a date no later than two calendar months from the end of the financial year and at a venue to be determined by the Board.

NOTICE OF GENERAL MEETING

- (a) Notice of every General Meeting shall be given to every Member entitled to receive notice, at the address appearing in the Register kept by the Association. The auditor and Directors shall also be entitled to notice of every General Meeting, which shall be sent to their last notified address. No other person shall be entitled as of right to receive notices of General Meetings.
- (b) Preliminary notice of a General Meeting should be issued 42 calendar days prior to the date of the meeting calling for notices of motion and any other business to be conducted at that meeting.
- (c) A notice of a General Meeting shall specify the place and day and hour of meeting and shall state the business to be transacted at the meeting.
- (d) At least 14 calendar days' notice of a General Meeting shall be given to those
Members entitled to receive notice, together with:
 - (i) the agenda for the meeting; and
 - (ii) any notice of motion received from Members

BUSINESS

- (a) The business to be transacted at the Annual General Meeting must include;
 - (i) recording of Attendance and Apologies.
 - (ii) confirmation of previous Annual Meeting Minutes.
 - (ii) presentation of the Annual Report of the Board.
 - (ii) presentation of the financial statement and audit report for the last financial
year.
 - (iii) the election of Directors under this Constitution,
 - (iv) the motion for affiliation with the Branch, SLSQ and SLSA.
 - (v) the motion recognising the affiliation of the Association's supporters club;
 - (vi) the appointment of the auditors for the present financial year; and
 - (iv) general business without notice of the Association.

- (b) All business that is transacted at a General Meeting, and all that is transacted at an Annual General Meeting, with the exception of those matters set down in clause 20(a) shall be special business.
- (c) No business other than that provided on the notice shall be transacted at that meeting.

NOTICES OF MOTION

Members shall be entitled to submit notices of motion for inclusion as Special Business at a General Meeting. All notices of motion must be submitted in writing to the Secretary not less than 21 calendar days (excluding receiving date and meeting date) prior to the General Meeting. Notices of motion must include a mover and seconder.

Only Members eligible to vote shall be entitled to submit notices of motion for inclusion as Special Business at a General Meeting.

VOTING AT GENERAL MEETINGS

Members entitled to Vote

Each Member over the age of 15 years and entitled to vote as set out in **clause 11.1** shall have one vote at General Meetings which, subject to this Constitution, shall be exercised by that Member.

As per Section 11, Clause 11.1, Members, pages 11 to 13 of the Constitution:

Active, Reserve Active, Long Service, Past Active and Life Members have the right to be present, to debate and to vote at General meetings.

Probationary, Junior Activities (Nippers), Cadet and Honorary Members shall not have voting rights.

Associate, Award and Associate Junior Activities Parent Members shall not have voting rights unless elected to office or position, which is provided with voting rights by this constitution.

Casting Vote

Where voting at General Meetings is equal, the chairman may exercise a casting vote.

SUBSCRIPTIONS AND FEES

As per Constitution page 13

The annual membership subscription (if any) and fees payable by Members to the Association, the time for and manner of payment shall be determined by the Board from time to time.

Such annual membership fees are payable for the ensuing season to be eligible to stand for office and vote at the Annual General Meeting.

QUORUM

No business shall be transacted at any General Meeting unless a quorum is present at the time when the meeting proceeds to business. A quorum for General Meetings shall be 30 Voting Members over the age of 15 years. A quorum for Special General Meetings shall be 50 Voting Members over the age of 15 years of age or 20% of the Voting Members whichever is the greater.

PROXY'S

Proxy voting shall not be permitted at any General Meeting.

TRAINING ROOM AND IRB SHED

FROM THE TRAINING ROOM AND IRB SHED

It has been another busy season for the training team, running Bronze and SRC training, Radio Operations, SSV and Tractor courses as well as an IRB Drivers/Crew course. We have all been in the thick of it but fortunately due to our numbers, we have been able to share the courses around and assist each other when needed. We have a very good training team at the moment, consisting of Chris Van Dorn, Amanda Higgerson, Geoff Carlin, Deb Scottman, Jy Taylor, John Manning and myself. Everyone has put in a great deal of time and effort throughout the season and I wish to thank them all sincerely for a job well done.

We are not finished yet however, new courses set for later in the year consist of an IRB Driver/Crew course commencing on Sunday 2/7/23 with assessment on the 30/7/23, five Skills Maintenance days scheduled for Sunday 20/08/23, Sunday 17/9/23, Saturday 21/10/23/ Sunday 19/11/23 and Saturday 10/12/23. We have an Intense SRC/Bronze course scheduled in the September school holidays, Monday 25/9/23

to assessment day on Monday 1/10/23. Reminders for these

training days will be sent out progressively as the year moves on so if you are interested in any of the courses, please register with the office so as resources can be allocated.

While the trainers conduct these courses, they could never be run without water safety personnel, for this I would like to thank Darren Free and his gang of helpers, who turn up every day, in all conditions, and provide water safety for our trainees. We could not do our jobs without you so a big thank you to you all from the Trainers.

About a month or so ago we conducted an IRB Driver/Crew course. It was well attended with 10 Crew and 3 Driver trainees. The training group consisted of a great bunch of people, who were quick to learn and competent, thus making the training easy to conduct and fun. Jy Taylor, Chris Van Dorn and Ken Bemis put in a great effort with these people. Ken drove down from Brisbane every training day to help train the group and found the effort very rewarding. Ken and Charlie (Crew Trainee) received the applause for the largest wave to be punched through, and the

most airtime in the boat after. It looked spectacular and was efficiently and safely conducted. The course was great fun, everyone enjoyed it and all passed on assessment day. For the assessment an external assessor, from Rainbow Bay, was allocated to assess us, which we were happy with as it helps to validate our trainers and training. On assessment day the trainees dazzled the assessor, we did 1 person, then 2 person then 3 person rescues, inside the break, piling people into the boat, simulating a mass rescue, much more than was required for competency, but the guys were on a role. It was great to see and everyone passed with flying colours.

We finished the season with nearly all of our boats and motors fully operational. Over the easter

period the Zodiac IRB developed a leak in the keelson. This is very unusual, and I have not seen this happen before. The keelson is the inflatable backbone of the IRB, and if this is flat, or underinflated, can cause the boat to bend in half when punching a wave and can seriously injure both the Driver and Crew. The boat was subsequently taken out of service and is being repaired at this moment. Drivers and Crew, please check this compartment when doing your pre-operational checks.

That's about it from me, many thanks to the Board of Management for their help in meeting the needs of both the Training Team and the IRB,s. Also big thank you to Grant and Kristal for much needed administrative support through the season.

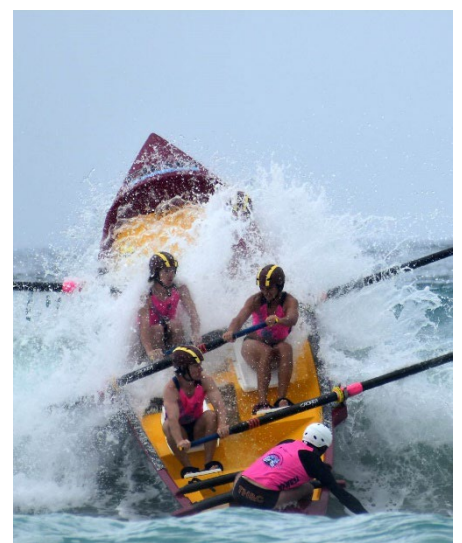

2022/23 Season Overview

- The club finished the season with 262 registered Nippers. This was up from 199 in the previous season.
- We saw a strong resurgence in numbers and attendance this season after the border challenges of the prior two years. Our numbers are still down from a high of 346 in season 2019/20.
- We were able to have our first full season of training in three years, and as a result saw some outstanding carnival performances across all age groups.
- We had 21 of our junior members achieve their SRC or Bronze awards and go on to start patrolling our beach.

President's Report

We were always going to have a more settled season with our Nippers this year – able to train in the one state, no cancelling of Sunday sessions, full attendance at carnivals, and finally able to be one team after the trials of the past two years. A strong increase in member numbers provided a

welcome challenge as we scrambled to ensure we had sufficient gear and clothing available for all Nippers. Our youngest age groups in particular have shown wonderful numbers in attendance and our future looks very solid for the years to come.

We welcomed a new Beach Coach this season – Chelsea Lane – and she quickly showed that she was going to further our performances on the beach arenas. Our competitive season was the most successful for some time, with some great performances in and out of the water. Jason and Kane oversaw good improvements in our water competitors, whilst Chelsea set our 'beachies' on fire, culminating in 6 competitors winning medals at Aussies. Huge congratulations go out to Zeke Zimmerle, Addison Free, Brock Osborne, Ruby Power, Noah McClure and Fletcher Bisgrove for their performances in Perth, and also to the many State Championship medallists this season. We have a great foundation for outstanding

results next season.

It was very pleasing to see so many of our young crew patrolling Greenmount Beach this year. Twenty-one of our younger members achieved their Bronze or SRC awards, and this was only possible with the support of our awesome Training team. A special mention should be made of Amanda Higgerson who showed patience and flexibility in supporting our Nipper kids and parents to get qualified this season.

The involvement of parents was again a highlight through the season. We had a good number of new carnival officials qualify, as well as water safety support. Nipper attendance at training numbered near 50 on occasion, but there was always adequate support to ensure things ran safely and efficiently. Engagement of parents and guardians contributes so much to the successful running of our club, and I'm sure this will continue into next year.

This was the year of our post-COVID recovery, and it was wonderful to see the renewed camaraderie with kids and parents alike. We truly have a blessed club, and the growth this season has put us in great stead to have a number of very successful seasons ahead. Financial Update

BUILDING DEVELOPMENT COORDINATOR

FROM THE BUILDING DEVELOPMENT COORDINATOR

At the time of writing this report progress with the building works are on track for a mid to end of June completion. This will complete the third stage of the redevelopment of the club that comprised the new entrance, first aid room, new supporters offices and storerooms, upgrade of the old DOSA and a new function room. The remaining future scope of work to complete the redevelopment is a general upgrade of the Supporters 1st floor facilities, including air conditioning, an upgrade and fit out of the kiosk. refurbishment of the surf club showers and toilets and additional surf club storage.

Stage 3 work has proved more complex than the first two stages due to the requirement to interface and open up much of the old building. This resulted in numerous latent conditions causing additional design work and delays to the program.

As part of the preliminary work to the function room it was discovered that the existing deck surrounding the western end of the building had significant structural issues and was

condemned by our structural engineer. The rebuild of the deck was obviously not included in our budget but I am pleased to report that the financial performance of the supporters club has allowed for this work to be funded outside of the loan. The only draw back to this additional work is that the completion of the kiosk will be delayed. However, it is intended to complete all demolition work within the kiosk prior to Hutchies leaving the site so that the shell of the kiosk will be ready for installation of services and fit out.

I am confident that members will be pleased with the new facilities and appearance of the club at the completion of Stage 3 work. The new function room should prove a success given the number of bookings already received in advance of its completion. Similarly, the upgraded kiosk should also add to the amenity and attraction of members and the general public to the club.

In an effort to contain costs some works have been undertaken by the club, such as landscaping, external paving, blockwork,

painting, floor coverings and artificial turf. In this regard I would like to acknowledge the efforts of Norm Mavor, Ken "Carpets" Rosenlund and Mick Bell who continually front up to undertake any work asked of them and save the club a lot of money.

The Old Boys contributions to the project are also appreciated and their financial support has allowed the club to undertake additional work without drawing on the loan or using surf club funds. Thankyou also to Shane

Bisgrove who allocated his fee for the design and landscape plans to the Nippers Club.

Lastly, I need to acknowledge the efforts of Craig Hickling. Craig has worked very closely with Hutchies imparting his expert knowledge to obtain a great result for the club and achieving value for money outcomes.

It is great to see members of the Surf Club and Supporters Club working as one team and providing many hours of free labour. Moving forward the club is in a very good place.

Isn't it great to see all areas of the Club doing so well – resulting in a very successful Season on Greenmount Beach and a positive atmosphere in our Club.

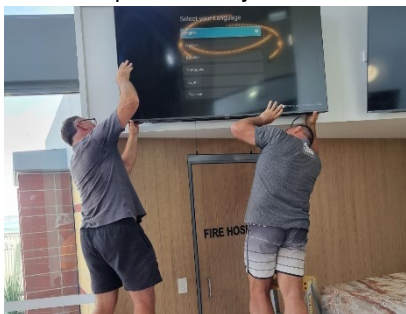

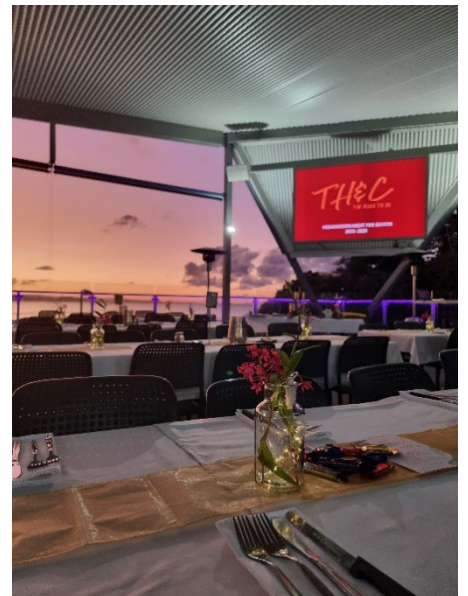

Our clubs Profit & Loss statement shows our best ever largely due to the donations from the Supporters Club which total over \$1.1million. This has been a great result from a Supporters Club coming off the back of the difficult Covid times. Their sound financial management has allowed us to commence in this last year the final stage of our renovations and as you can see, they are almost finished with the final claim to Hutchinson due to be paid next month.

As with all building projects we have had to deal with some further costs, in our case namely the veranda floor needing to be fully replaced in the renovation area.

These increases mean that the final fit out of the new kiosk is to be delayed until we can build up reserves to fund the completion. Our Westpac Loan will be fully drawn with the final Hutchinson's claim, the current interest rate is 6.74% on the full \$1.8 million loan. Our goal is not only to service this loan but to pay it down as quickly as possible. This obviously is dependent upon the continued success of our Supporters Club and being very mindful of all of our expenses going forward.

Please make sure that you support our Supporters Club as you can see the results with the monies transferred down this year. I would like to thank them for the great job they have done and continue to do.

In addition to the Supporters Club, I would also like to thank the building committee for all the work they have done with our final stage of renovations their hard work has allowed us a great renovation done in a very difficult building environment. Well done.

The Old Boys again deserve huge accolades with all their volunteering and fund raising, filling holes where funds and manpower are needed a great job that literally contributes hugely to our final financial result. Also, Grant Brown has greatly assisted me in my role as treasurer and I thank him for that.

Finally, I would like to remind everyone although we have achieved a great result with our final profit for the year, this money has largely been committed to the renovation and we still have the kiosk fit out to go and therefore monies are as tight as ever.



NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Corporate Information

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 1981* (Qld) and the *Australian Charities and Not-for-profits Commission Act 2012* (Cth). The committee has determined that the Charity is not a reporting entity.

Basis of Preparation

The financial statements are for the Tweed Heads and Coolangatta Surf Life Saving Club Inc as an individual entity, incorporated and domiciled in Australia. The Tweed Heads and Coolangatta Surf Life Saving Club Inc is an association incorporated in Queensland under the *Associations Incorporation Act 1981* (Qld) and is registered as a Charity under the *Australian Charities and Not-for-profits Commission Act 2012* (Cth).

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following Australian accounting standards have been applied in the preparation of these financial statements:

- AASB 101 - Presentation of Financial Statements
- AASB 107 - Statement of Cash Flows
- AASB 108 - Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1048 - Interpretation of Standards
- AASB 1054 - Australian Additional Disclosures

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Accounting Policies

a. Income Tax

No provision for income tax has been raised as the Charity is exempt from income tax under Section 50-10 of the *Income Tax Assessment Act 1997* (Cth). Tweed Heads and Coolangatta Surf Life Saving Club Inc is a Public Benevolent Institution (PBI). Further, Tweed Heads and Coolangatta Surf Life Saving Club Inc is endorsed as a Deductible Gift Recipient (DGR).

b. Comparative Figures

When required by the applied Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year. When required, comparative information is reclassified where appropriate to enhance comparability.

c. Economic Dependence

Tweed Heads and Coolangatta Surf Life Saving Club Inc is dependent on the Tweed Heads & Coolangatta Surf Life Saving Supporters Association Inc for funds used to meet its financial commitments. At the date of this report the committee members have no reason to believe the Tweed Heads & Coolangatta Surf Life Saving Supporters Association Inc will not continue to support Tweed Heads and Coolangatta Surf Life Saving Club Inc.

d. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Statement of Financial Position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

e. Critical Accounting Estimates and Judgments

The committee of management evaluate estimates and judgments in the financial report based on historical knowledge and best available information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Charity.

Key estimates

The estimate of the useful life of leasehold improvements, plant and equipment is reviewed at least annually to confirm that the remaining life of material assets is reflected on the asset register. There were no other critical accounting estimates to be considered during the year or during preparation of this financial report.

Key judgments

The methods of depreciation are used to provide a consistent usage of the useful life of leasehold improvements, plant and equipment. The methods also allow, where required, for the leasehold improvements, plant and equipment to be fully written down at a specific point in time such as the end of the lease term. There were no other critical accounting judgments made by the committee of management.

f. Contributions

If and when Tweed Heads and Coolangatta Surf Life Saving Club Inc receives non-reciprocal contributions from the government or other parties for nothing or a nominal value the contributions would be recognised at the fair value on the date of acquisition upon which time an asset is taken up in the Statement of Financial Position and revenue in the Statement of Profit or Loss and Other Comprehensive Income.

g. Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Grant revenue is recognised in the Statement of Profit or Loss and Other Comprehensive Income when the Charity obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the Charity and the amount of the grant can be measured reliably.

Donations and bequests are recognised as revenue when received.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

h. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of twelve months or less, and bank overdrafts.

i. Trade and Other Receivables

Trade and other receivables include amounts due from members as well as amounts receivable from other entities. Receivables expected to be collected within twelve months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

j. Inventories

Inventories are measured at the lower of cost and net realisable value.

k. Property, Plant and Equipment

Each class of leasehold improvements, plant and equipment is carried at cost or fair value less, where applicable, accumulated depreciation and impairment losses.

Leasehold improvements, plant and equipment

Leasehold improvements, plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of leasehold improvements, plant and equipment is greater than its estimated recoverable amount, the carrying amount is written down immediately to its estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1n for details of impairment).

Leasehold improvements, plant and equipment that have been contributed at no cost, or for nominal cost, are valued and recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of leasehold improvements, plant and equipment is depreciated on a straight line basis over the asset's useful life to the Charity commencing from the time the asset is held ready for use. The rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the Statement of Profit or Loss and Other Comprehensive Income. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained surplus.

I. Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the Charity during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within thirty days of recognition of the liability.

m. Employee Benefits

Retirement benefit obligations - superannuation benefits

All employees of the Charity receive defined contribution superannuation entitlements, for which the Charity pays the fixed superannuation guarantee contribution (currently 10.5% [11.0% from 01 July 2023] of the employee's ordinary times earnings) to the employee's superannuation fund of choice. All obligations for unpaid superannuation guarantee contributions are measured at the (undiscounted) amounts expected to be paid when the obligation is settled and are recognised as trade and other payables under current liabilities in the Charity's Statement of Financial Position.

Short-term employee benefits

Provision is made for the Charity's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service, including wages, salaries, annual leave and long service leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled. The Charity's obligations for short-term employee benefits are recognised as trade and other payables under current liabilities in the Statement of Financial Position.

m. Employee Benefits (continued)

Long-term employee benefits

The Charity only classifies employees' long service leave entitlements as long-term employee benefits as they are not expected to be settled wholly within twelve months after the end of the annual reporting period in which the employees render the related service. Provision is made for the Charity's obligation for long-term employee benefits, which are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Upon the remeasurement of obligations for long-term employee benefits, the net change in the obligation is recognised in profit or loss classified under employee benefits expense.

The Charity's obligations for long-term employee benefits are recognised as provisions under non-current liabilities in its Statement of Financial Position, except where the Charity does not have an unconditional right to defer settlement for at least twelve months after the end of the reporting period, in which case the obligations are recognised as trade and other payables under current liabilities in the Statement of Financial Position.

n. Impairment of Assets

At the end of each reporting period, the committee members assess whether there is any indication that an asset may be impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount in accordance with another Standard (e.g. in accordance with the revaluation model in AASB 116). Any impairment loss of a revalued asset is treated as a revaluation decrease in accordance with that other Standard.

Where it is not possible to estimate the recoverable amount of an individual asset, the committee members estimate the recoverable amount of the cash-generating unit to which the asset belongs.

o. Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term.



The Committee's responsibility also includes such internal control as the Committee Members determine is necessary to enable the preparation of a financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the Committee is responsible for assessing the ability of the Charity to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Committee either intend to liquidate the Charity or to cease operations, or have no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with the Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Charity's internal control.



We communicate with the Committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the Committee with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

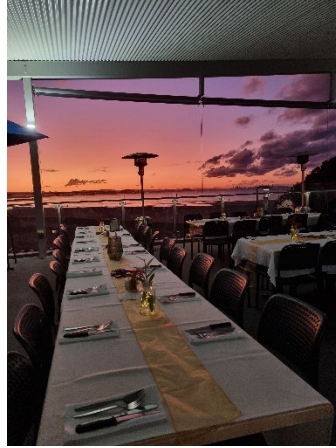
